- Arranged tax give-aways to Tesla, Google and Solyndra, engaged in sex scandal, refused to supply same benefits to witnesses, forced out of politics. Known conflict with DNC financiers.

Senator Darryl Issa

- Launched investigations and condemned suspects actions in public

- Launched investigations and condemned suspects actions in public

- Launched investigations and condemned suspects actions in public

Rahm Emanuel - White House Chief Of Staff

- No response from primary offices. Witnesses sued associated entity IN-Q-TEL for attacks on witnesses. Some agency staff provided assistance to Congressional investigators. Known conflict with DNC financiers.

Mr. Robert Gibbs - White House Press Secretary

- Witnesses provided Mr. Gibbs, and his full staff, with a complete written report of charges and asking for help. Mr. Gibbs suddenly resigned upon receipt of the report. Known conflict with DNC financiers.

Christine Lakatos

- Green Corruption Editor. Opened investigations

Mr. Erick Strickland – Director, National Highway Safety and Transportation Agency

- Witnesses provided Mr. Strickland, and his full staff, with a complete written report of charges and asking for help. Mr. Strickland suddenly resigned within 48 hours upon receipt of the report. Known conflict with DNC financiers.

Mr. Steven Chu - Secretary of Energy, U.S. Department of Energy

- Steven Chu resigned in shame after receiving witness demands for corruption investigation and was sued for corruption. Known conflict with DNC financiers.

Mr. Ernest Moniz - Secretary of Energy, U.S. Department of Energy

- Refused to respond. Known conflict with DNC financiers.

Mr. John Doerr

- Primary beneficiary of the corruption. Senior Partner Kleiner Perkins. DNC financier

Mr. Lachlan Seward - Loan Director, U.S. Department of Energy

- Lachlan Seward resigned in shame after receiving witness demands for corruption investigation and was sued for corruption. Known conflict with DNC financiers.

Mr. Daniel Cohen - Attorney, U.S. Department of Energy

- Daniel Cohen resigned in shame after receiving witness demands for corruption investigation. Known conflict with DNC financiers.

Senator Nancy Pelosi

- Refused to respond. Known conflict with DNC financiers

News Reports, Regulatory and Law Enforcement Reports appear to conform and validate the following:

- Steven Chu and Department of Energy staff sabotaged most companies that competed with Afghanistan lithium mining holdings of campaign investors
- Google holds various interests in Elon Musk's companies and his suppliers
- Google and Elon Musk's companies would not be in existence today if not for state and federal government hand-outs at taxpayer expense
- White House senior executives have ordered federal agencies to “stand down”, “take no action”, “cover up” or “punish reporters” in these charges
- Goldman Sachs had a managing, profit-taking and political campaign finance relationship with almost every suspect, Afghan commodity manipulation charge and Google and Tesla owner
- Google manipulated the Internet to attack and destroy politicians, reporters, companies and individuals who competed with Google, Elon Musk or Kleiner Perkins-related assets
